CONSENT

The photographer may only use the images and recordings for purposes other than those agreed herein (e.g., on social media, in illustrated books), and thus promote them, with the prior written consent of the person giving approval. Each use of company names, trademarks and other protected designations of the building contractor/owner or their affiliated companies for purposes other than those agreed herein requires the prior written consent of the building contractor/owner. This agreement shall not operate to confer any rights in or to intellectual property (e.g.,

patents, utility models, trademarks, designs) or license to use intellectual property, copyrights and related proprietary rights or any other rights, nor impose any obligation to grant any such rights. This agreement applies for an indefinite term.
